






Our collaboration with the Science Museum of Minnesota is just one example of how we are uniting stakeholders around our different projects-in this case the River Balcony. This summer, we will be collaborating with the museum and the National Park Service to offer public programs, including lunchtime patio talks on the Kellogg Plaza overlooking the river.

# **INSPIRING INVESTMENT**

We are working to spark investment along the riverfront in Saint Paul through strategic partnerships and innovative programming. The Mississippi River Learning Center has been singled out as Saint Paul's top capital investment project in 2024.

The center is also receiving crucial support from the U.S. Forest Service Urban Connections program, allowing us to offer environmental education opportunities at the site as it develops.

"The Urban Connections program seeks to foster an understanding of the role natural resources play in young people's lives. The Mississippi River Learning Center is poised to be a national leader in providing youth education programs and we are excited to join the effort..." — Dan Dressler, Urban Connections Coordinator, U.S. Forest Service The recent decision by Saint Paul voters to increase sales tax for public infrastructure and parks maintenance presents a prime opportunity for advancing design developments along the Great River Passage.

These public funds, combined with state bonding allocations, create a solid foundation to leverage private philanthropy. Donors recognize the multiplier effect of supporting the conservancy, further amplifying our impact.

As we navigate fundraising campaigns and bonding requests in 2024, we remain committed to leveraging public support to realize our vision for a vibrant and accessible riverfront community.

# BUILDING AWARENESS & ACCESS

We are dedicated to building access and awareness of the Mississippi River in Saint Paul, ensuring that all communities can enjoy and appreciate this vital natural resource.

Through initiatives such as the East Side River District project, we are working to heal and connect communities to the river, focusing on Indigenous groups and underrepresented populations.

We have re-launched community engagement around Pig's Eye Regional Park and the surrounding landscape. Over the next year, we will work with partners, including Urban Roots and Wakaŋ Tipi Awaŋyaŋkapi to develop programs and coordinate meetings that engage residents of the East Side as well as Indigenous communities.








Upcoming activities include bird watching hikes, wildlife surveys, and habitat restoration experiments.

#### ABOUT THE GREAT RIVER PASSAGE CONSERVANCY

The Great River Passage Conservancy was founded in late 2018 to rally philanthropic support for the Great River Passage Initiative's river-focused projects designed to build economic vitality along Saint Paul's stretch of the Mississippi River. All on Dakota homeland, these three projects — the River Learning Center and National Park Service Headquarters, River Balcony, and East Side River District — respond to the enduring qualities of the Mississippi River that link it to Saint Paul and the wider region's historical, cultural, environmental, and economic well-being.

With Saint Paul's 17 miles of river, 26 miles of river edge, and 3,500 acres of publicly owned land, we have a unique opportunity to become the River Capital and unite our region's two greatest assets: its people and one of the three great rivers of the world, the Mississippi.

By advancing major projects along the Mississippi River that allow all people to experience the river in new and equitable ways, the Great River Passage Conservancy fosters environmental stewardship, community health, and economic development.
